## RESOLUTION ON THE DEATH OF ROY S. F. ANGLE

WHEREAS, on December 20, 1978, Almighty God called from our midst our friend and fellow lawyer, Roy S. F. Angle, and

WHEREAS, Roy, a lifetime resident of Franklin County, Pennsylvania, graduated from the University of Pennsylvania, attended the University of Pennsylvania Law School from 1940 to 1942 when his legal education was interrupted by his service with the United States Army, during which he served with distinction and was awarded both the Bronze Star and the Purple Heart.

Upon his return from service, he completed his legal education at Dickinson School of Law and was admitted to practice before the Pennsylvania Supreme Court and the Franklin County Courts in 1947.

Until 1951 he was associated in the practice of law with N. F. Keller. He then became a sole practitioner until April, 1977, at which time Gregory L. Kiersz became associated with him.

During his more than 30 years of practice, he maintained offices both in Waynesboro and in Greencastle, becoming active both as an advocate and a solicitor. He unstintingly, conscientiously and with success gave of both his time and ability in both fields.

He was active as a Solicitor in the municipal law field, serving Antrim Township Supervisors and Quincy Township School District and at the time of his death was Solicitor for both the Quincy Township Supervisors and Water Authority, the Hamilton Township Supervisors and Water Authority and the Montgomery Township Supervisors.

For many years he served the Franklin County Legal Aid Society, the Franklin County Board of View, the Pennsylvania Weather Modification Board and the United States Army Intelligence Corps and was an active member of the Franklin County Bar Association as well as the Pennsylvania and the American Bar Association.

He was especially interested in creating the Franklin County Legal Journal, doing much of the preliminary work in the gathering of legal opinions in the 1960's and in the preparation for the present Franklin County Legal Journal, serving as its first President and continuing to serve in various other capacities.

He gave liberally of his time and assets to the community, donating the present Waynesboro Chamber of Commerce Building, served as President of the Waynesboro YMCA and served his Church in many capacities.

Further, the Franklin County Bar Association, while accepting the inevitable, keenly feels the loss it has suffered and desires to preserve a record thereof and thus bear testimoney to the esteem in which he was held.

THEREFORE, BE IT RESOLVED, that the Franklin County Bar Association, in Special Meeting, assembled this 23rd day of December, 1978, records an expression of its high regard for Roy S. F. Angle and for his service to his profession and his community and to express its deep sense of loss, as he will be sorely missed and deeply mourned by his family, friends, associates and clients.
